







Right and Front View with EMC Plate











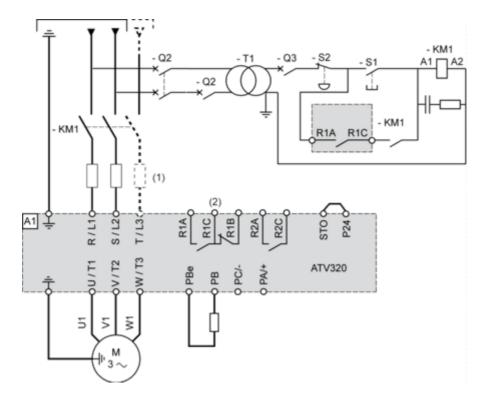




#### **Diagram with Switch Disconnect**

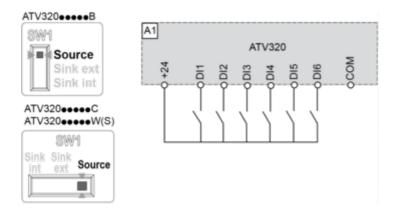

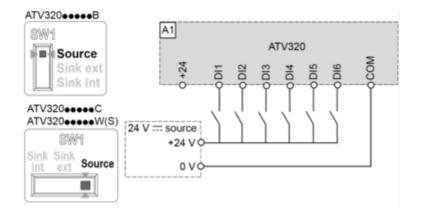

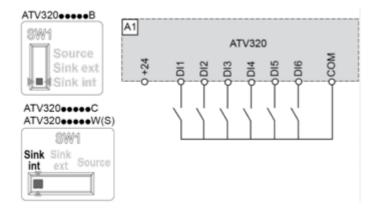


Switch SW1 set to "Source" position and use of an external power supply for the DIs.


